PURPOSE AND LEGAL BASIS AND DURATION. It should be noted that the process will take place as follows:

This treatment will always be based on principles of correctness, lawfulness, transparency and protection of the privacy and rights of the interested parties.

COMPULSORY OR OPTIONAL NATURE OF DATA PROVISION. We inform you that, taking into account the purposes of the processing as illustrated above, the provision of data is mandatory and their failure, partial or incorrect provision may have, as a consequence, the failure to finalize the contract.
